Now, therefore, the undersigned does hereby agree as follows:

- 1. The undersigned **Parent/Guardian** consents to the participation of the Junior Sailor in the Program and agrees that this consent will extend to the MANHASSET BAY YACHT CLUB (hereinafter referred to as "MBYC").
- 2. The undersigned **Parent/Guardian** consents to the participation of the Junior Sailor in all regattas, clinics, and sailing events (hereinafter collectively referred to as "Regattas") which are a part of the Program and acknowledges that said consent is without exception within the limits proscribed within, unless a specific exception is noted herein. The undersigned further agrees that this Agreement will extend to the benefit of yacht clubs/sailing associations (hereinafter referred to as "Host Clubs"), which are the host to or venue of such Regattas, and to the Junior Sailing Association of Long Island Sound, Inc. (hereinafter referred to as "JSA"). The list of Host Clubs is available on the JSA of LIS web site at <a href="http://www.jsalis.org">http://www.jsalis.org</a>. The undersigned further acknowledges that Parent/Guardian has reviewed the JSA 2020 Schedule prior to the execution of this document and further understands that changes to the schedule, including but not limited to changes of venues, may be made at any time. The up-to-date Regatta schedule is published at the JSA web site <a href="http://www.jsalis.org">http://www.jsalis.org</a>. If exceptions are desired please enter the names of the regattas or host club(s) to which consent is not given \_\_\_\_\_\_\_.
- 3. The undersigned waives any claims against and releases any obligation of the MBYC, each Host Club, the JSA and all of their respective members, employees, agents and all persons serving as members of the Race Committees or Juries or any other person acting in any capacity for the conduct of the program or any Regatta in relation to any loss, injury or damage, on land or at sea, to the Junior Sailor or to the boat or other property of the undersigned or the Junior Sailor to the fullest extent permitted by law.
- 4. The undersigned agrees to reimburse MBYC, any Host Club, the JSA and all of their respective members, employees, agents and all persons serving as members of the Race Committees or Juries or any other person acting in any capacity for the conduct of the Program or any Regatta for any loss or damage to property, and hold MBYC, each Host Club and the JSA harmless from any claim, loss or injury caused by the negligence, or misconduct of, or failure to exercise reasonable care by the Junior Sailor.
- 5. I hereby assign and grant to "MBYC" the right and permission to use and publish, without compensation, the photographs/film/videotapes/electronic representations and/or sound recordings made of me or my minor child at all MBYC activities, and I hereby release MBYC, the activity coordinators, and all employees, volunteers, related parties, or other organizations associated with the activity from any and all liability from such use and publication, and waive any rights I may have under Section 51 of the New York State Civil Rights Law. I hereby authorize the reproduction, sale, copyright, exhibit, broadcast, electronic storage, and/or distribution of said photographs/film/ videotapes/ electronic representations and/or sound recordings on the website of MBYC or in other materials which display the various recreational and other activities available at MBYC.
